#### 3 Minutes of last Forum meeting (7th November 2019) and Matters Arising

The minutes of the last Forum meeting were agreed.

There were no matters arising that were not on the agenda.

#### 4 Future of BAF meetings – an update following a survey of members

The results of the survey, initiated due to low numbers at previous meetings, was shared and discussed.

The key findings were:

- 20 organisations contributed to the survey.
- The majority of people found the meetings useful.
- The majority of people found the content of meetings useful and relevant. Networking is particularly important.
- Many people find attending 3 meetings a year difficult due to time pressures.
- There was a preference for meetings in the morning.

The Steering Group have considered all the feedback and proposed the following:

- A reduction from three to two meetings a year
- One in Bedford and one in Central Bedfordshire (Ampthill or Flitwick area)
- Morning meetings, including lunch to allow for more networking.

It was also agreed to roll out use of the email distribution system to allow members to quickly disseminate information to each other.

This was agreed by all present.

#### 5 Discussion: funding opportunities for the advice sector

Those present discussed funding opportunities, the challenges facing the sector, and the current funding sources that they were considering or receiving support from.

**Sam – Macmillan Welfare Rights** – The service will now continue beyond March 2020, with staff being given permanent contracts.

**Sylvia - Money Advice at St Andrews –** Sylvia took the opportunity to highlight the Alderman Newton Educational Foundation, which can make small grant to individuals in the Bedford area.

**Karen - Salvation Army** – A new service leaflet has been produced. Karen will send to Martin for distribution to members.

**Chera - DRC/Advice Central -** Advice Central have produced new publicity leaflets for partners to use and share. Copies were available at the meeting for partners to take away.

**Elliott - Grand Union Housing Group –** Elliott reminded colleagues that staff are now able to outreach as required across Bedfordshire.

**Len - Autism Beds** – Len highlighted the two charity shops that Autism Beds currently have, and the opportunity for organisations looking to offer recognised training qualification to work in partnership, as Autism Beds is a registered Open College Network Assessment Centre.

**Martin - CVS -** Martin discussed the issue of how the sector might better co-ordinate donations of goods, equipment and food, etc.

#### 7 Update on BAF activities (including training)

The two training courses were popular and dates for future meetings are being considered.

The Bedfordshire Benefits Network continues to see good attendance. The next meeting is on the 12<sup>th</sup> March in Bedford.

Len attends the Bedford Anti-Poverty Action Group (BEDIPAG), which is discussing organising a school uniform exchange system in the summer.

#### 8 Update on Central Bedfordshire Advice Strategy and VCSE Review

Sarah provided an update on a number of issues

### **BAF** training

BAF ran 2 courses in late 2019.
